MEETING REPORT:

1. Opening:

The AFCC Board Meeting opened at the AFCC HQ and Museum, Boston, MA at 1830 hrs with the Pledge of Allegiance led by LTC Brett Conaway..

2. Secretary's Report:

COL(MA) Saluti presented the AFCC 24 FEB 2015 BOD Meeting Minutes. The Minutes were reviewed and approved.

3. Treasurer's Report:

CW3 Stedman reported that there is a balance of approximately \$6.5K in the AFCC Operating Account. All bills have been paid. There is approximately \$15K in the Restricted Funds Accounts. CW3 Stedman also presented a monthly/annual income and expense analysis that included the rental of the two (2) parking spaces and the Society of Colonial Wars' 3rd floor front room. The Treasurer's Report was unanimously approved.

COL Soldani presented the Finance Committee update. He stated that there is approximately \$417K in the brokerage account.

8. House Report:

10. Active Unit Report:

LTC Blake presented the Active Unit Report:

- The Massachusetts National Guard Reaction Force comprising personnel of the 211th Military Police Battalion, 102nd Security Forces Squadron, and 104th Security Forces Squadron successfully supported the Massachusetts State Police and other civilian law enforcement agencies at the 2015 Boston Fourth of July celebration. The mission lasted from 3 to 5 July and included approximately 150 personnel conducting police operations in Boston's Esplanade area.
- A platoon of the 972nd Military Police Company departed Logan International Airport on SUN, 6 SEP en route to Germany for a three-week Overseas Defense Training mission, during which the MPs will conduct a law and order mission on U.S. military installations.
- The 747th Military Police Company will conduct its Family Day on SUN, 13 SEP at 1100 in the Ware Knights of Columbus Hall. All VAFCC members are warmly welcomed to attend and introduce themselves to the company commander, CPT Tyler Field.
- The battalion is looking forward to the Association Golf Tournament on MON, 21 SEP.
- The 972nd Military Police Company was recently selected to receive the Region 1 Army Award for Maintenance Excellence.
- The next unit event will be the 1-4 OCT 2015 Inactive Duty Training period (MUTA 8) at Fort Devens during which time the entire battalion will drill together and range operations will be conducted.
- Two female officers recently graduated from U.S. Army Ranger School and we are pleased to report that one of these newest Rangers, Captain Kristen Griest, is an MP Captain
